

# Weddings at the Church of St Lawrence, Barlow

The Church of England is the *established* church, so if one or both of you live in the church parish, the law allows you to be married here. The parish boundaries include:

- Barlow and Commonsides;
- Barlow Lees, Brindwoodgate, Leash Fen, Moorhall, Barlow Grange, Newgate, Bole Hill, Wilday Green, Wellspring;
- Oxtun Rakes is on the border.

The church parish does *not* include Millthorpe or Unthank.

If you *don't* live in the church parish, you may still be married in Barlow church if you can *demonstrate* some attachment to the church—for example:

- if you were baptised here or confirmed from here;
- if you used to live in the parish for at least 6 months;
- if you worshipped here for at least 6 months;
- if your parents or grandparents were married in the church; or
- if you attend services regularly for *at least six months*.

These rules are not invented by the church or by me: they are English ecclesiastical and civil law. Exceptions are made from time to time, for example by being granted a Special Licence from the Archbishop of Canterbury, but this is expensive, and not automatic.

I have a legal duty to be satisfied that you can lawfully marry in the church before I can fix the date and time with you. To do that, I need to see *both of you* in person. It speeds things up if you fill in this form, sign it, and bring it with you.

**Please also bring with you photographic proof of identity for both of you.**

Please note:

- If either of you has been married before, and your former husband or wife is still alive, please contact me *immediately*.
- If either of you is not a UK national, please contact me *immediately*. DO NOT WAIT.

In a few cases depending on circumstances, it may be necessary for me to obtain legal advice before I can say yes or no, **so do not make any firm arrangements until I have given a definite go-ahead.**
